OWNERSHIP & COPYRIGHT

- 1_1 The digital files downloaded to your computer contain font software that is the intellectual property of the font's respective designers, represented herein by GoodEggs TypeFoundry
- 1_2 By purchasing the license, you become a licensed user, not an owner, of the fonts. To 'purchase a font' is simply to purchase a license to use it in accordance with this agreement. GoodEggs TypeFoundry retains all copyrights to the fonts after purchase.

LAWFUL USE OF PRODUCT

- 1_3 You may not sell, lease, sublicense, or otherwise assign or transfer any rights, duties or obligations under this agreement, in whole or in part, to any person or third-party, including by merger.
- 1_4 You may not distribute, lend, rent out, sell, give away, or share the font files for any reason not stated in this agreement.
- 1_5 You are not permitted to modify the fonts using font manipulation software to create a usable font without first gaining the express written permission of GoodEggs TypeFoundry to do so.
- 1_6 Licences are non-transferrable; the licensee is fixed at the time of purchase. As such, you may not transfer licences to clients once work utilising the fonts has been completed; the client must hold their own license to use the fonts, purchased either by them, or by you on their behalf.

WARRANTY & LIABILITY

- 1_7 Every care has been taken to produce our fonts to the highest standard, but technical issues can sometimes occur. If you do experience technical issues, we will do our best to resolve them, and if we are unable to resolve any technical issues arising from defective fonts then you will be due a full refund on your purchase, given that you request it within the first 30 days after purchase. Any refund terminates your license to use the fonts, which must then be deleted. Refunds will be given under no other circumstances.
- 1_8 GoodEggs TypeFoundry takes no responsibility for damage caused to a user's hardware, software or a loss of income that may have occurred as a result of downloading, installing or using GoodEggs TypeFoundry fonts. All GoodEggs' fonts are installed and used entirely at the owner's own risk and GoodEggs TypeFoundry cannot be held responsible.
- 1_9 Any breach of the terms of this agreement will immediately terminate your license to use the fonts. After termination of the license you must destroy any copies of the fonts in your possession.

PERMITTED USES	2_1	A trial license gives you the right to use the fonts for the purposes of trial, testing, and the evaluation of their suitability for a project; the fonts may not be used to produce any finished work.
	2_2	A trial license gives you the right to use the fonts in the production of printed images, but only for the purpose of your own evaluation, or for the purpose of privately sharing with clients when seeking approval in the context of a creative project.
	2_3	A trial license gives you the right to use the fonts in the production of static digital images in raster formats (e.g. files ending in .PNG, .JPG), but only for the purpose of your own evaluation, or for the purpose of privately sharing with clients when seeking approval in the context of a creative project.
	2_4	A trial license gives you the right to embed the fonts into electronic documents, but only for your own viewing and printing.
	2_5	A trial license gives you the right to use the fonts in the production of student work; that is, creative work produced by students within the context of their education within the creative arts. Such work may only be shared within the confines of the student's educational environment; a commercial license is required for the public distribution of such work.
	2_6	A trial license allows you to install the fonts on up to 3 workstations, or to be used by up to 3 users. The users must be working for the same organisation within the same location (or inhabit the same household).
RESTRICTIONS	2_7	A trial license does not give you the right to install fonts onto web servers for the purpose of serving live text to webpages; a web license is required for this purpose. A trial license does not give you the right to embed fonts into apps.
	2_8	Font files must not be converted to any other file formats than they were delivered in by GoodEggs TypeFoundry.
